

Gross Premiums Written
(in Php millions)





Net Premiums Written

Our Risk-Based Capital Ratio

The RBC requirement is a statutory minimum level of capital that is based on two factors:

- 1) an insurance company's size; and
- 2) the inherent riskiness of its financial assets and operations. That is, the company must hold capital in proportion to its risk.


